1. Complete all sections of the booking form and send it with your payment, which can be paid by Bank Transfer, Postal Cheque, Euro Cheque, Visa or MasterCard to info@erin-school.com.
2. Upon receipt of your booking form and payment we will confirm your booking. If payment is being made by bank transfer you must enclose a copy of the bank transfer with your booking form.

4. Payment for the courses by visa clients must be paid to a segregated account (Escrow) of PaytoStudy and a copy of payment order must be sent to PaytoStudy. The funds are kept in escrow account of PaytoStudy until the visa is approved. Refunds are arranged within 3 weeks of the visa refusal and customer's bank account details receipt by the school.
5. Learner Protection Insurance is compulsory for all students studying in Ireland, it is part of the legislation covering English language schools who take non-EU students in Ireland. Every student must purchase learner protection insurance, Erin School offers this insurance through O'Driscoll O'Neill at a cost of 100 euro (covering the fees up to 2500 euro)

Insurance and Health

Participants from EU countries should obtain form EHIC from their local Social Welfare Office. Any participant undergoing ongoing medical treatment must provide a medical certificate. Such participants should also bring to Ireland a supply of medicine sufficient to cover their stay. All participants should provide their own basic health and travel insurance.

The school offers medical insurance via the broker O'Driscoll O'Neill to all academic courses students. The fee is 165 euro. Summary of cover. This is a summary of cover and does not contain all the terms and conditions which can be found in the Group Policy document number IAS84420, a

copy of which is available upon request from your school {college or from O'Driscoll O'Neil the Intermediary.

Please take time to make sure you understand the cover it provides. Cover is underwritten by ACE European Group limited. The MediCover Student Private Medical Expenses Insurance covers Insured Persons, aged' under 60, whose Country of Origin is outside the EEA and who, whilst in Ireland for the purpose of attending an academic course with the Insured, during the period of insurance, suffer an injury resulting in death or disablement; incur medical expenses following illness requiring hospitalisation or following an accident; or require to be indemnified should they become liable for some unintentional injury, illness or damage to the property of another.

Who Can Be Covered?

Students, aged under 60, whose Country of Origin is outside the EEA, whilst in Ireland for the purpose of attending an academic course with the Group Policyholder B Any Partner, aged under 50, of a person described in Category A when the Intermediary and ACE and agree to include such person in this insurance,

C, Any Child of a person described in Categories A or B when the Intermediary and ACE agree to include such person in this insurance Pre-Requirements For Cover To Apply As with all insurance policies, other than life assurance, the policy covers only unexpected and unforeseen events. This policy provides cover for 2 500 000 euro for medical expenses (including dental expenses necessitated by bodily injury), nursing home and ambulance charges and unlimited expenses for emergency repatriation, Funeral expenses are limited to 1000 euro and physiotherapy, homeopathy, osteopathy or chiropractic treatment is limited to 1000 euro An excess of 100 euro per claim applies,

In case of injury, the benefit payable in respect of death, loss of two or more limbs, or loss of sight in both eyes, is 10 000 euro. In the case of loss of one limb or loss of sight in one eye the benefit payable is 5000 euro.

Personal liability cover included with a limit of indemnity 5000 000 euro.
